1. Important Notes:

- 1. Applications of such candidates, who have not submitted their final result by 09th August, 2019, have not been considered, as obtaining merit on the basis of final aggregate %age of qualifying examination was not possible.
- 2. Candidates are advised in their own interest to report the mistakes / discrepancies, if any, in this merit list, to the Director of the Institute in writing or by E-Mail at mca@bvicam.ac.in, latest by **10.08.2019** upto **09:00 p.m.**
- 3. On account of the delay in the admission process, it has been observed that the overall response of the aspiring candidates for admission in the Management Category is very poor and only limited number of candidates have applied by the last date, which was 09.08.2019. Further, no candidate of any of the Reserved Categories (SC/ST/Def./PwD) has applied. In view of this and considering the larger interest of the aspiring candidates, such candidates of Reserved Categories (SC/ST/Def./PwD) and General Category, who are still desirous of taking admission in the Management Category and could not apply by the last date, can also report on 11.08.2019 upto 04:30 p.m. along with all the required documents and fill the required application for admission against the vacant seats in the Management Category. However, their candidature shall be considered for admission in the Management Category, only during 2nd Counselling, only if the Merit List displayed above is exhausted and the seats remain vacant. For this, a Supplementary Merit List of all such candidates, having reported and applied on 11.08.2019, shall be prepared which will be used for admission against vacant seats (if any), during 2nd Counselling, only after exhausting the Merit List displayed above.
- 4. The given list is provisional subject to the verification of obtained marks from the final result and other details of candidates with reference to the documentary evidence for his / her eligibility, as required under the rules of GGSIP University, New Delhi. If any discrepancy is found during the verification of the documents at the time of the admission, before allotment of the seat, the Merit List may change, and in that case, the admission will be carried based upon the revised Merit List.
- 5. Invitation for Counselling does not guarantee any admission. Please note that the Counselling / Admission shall continue till the vacancy remains and shall be stopped as and when the seats are filled up.
- 6. Candidates shall attend Counselling on their own expenses, in all respects, after confirming their own Eligibility as mentioned in the Admission Brochure of the University for the Academic Year 2019-2020. Candidates must also check the University Website for the list of documents required at the time of the counselling.
- 7. The allotment of seats to the candidates will be made only when they attend the counselling session, in person, along with all the required original documents along with two sets of photocopies, as listed out at the University Website, 05 latest colour photographs and the total fees of the Institute in form of Demand Draft / Cheque / Online NetBanking. Please note that in absence of any of the documents / fee, at the time of Counselling, the claim to the seat allotment shall stand cancelled.
- 8. Candidates under "NOT ADMITTED" Category only shall be considered for admission against 10% Management Quota Seats. It may further be noted that a candidate, who has taken admission at any other Institute of the GGSIP University, New Delhi, under MCA Programme in 2019-2020, is NOT ELIGIBLE, as she / he shall be considered as ADMITTED STUDENT.

2. Seat Matrix:

Further, in absence of the required candidate(s), in the applicable categories, the Seats of that category shall be converted as per the standard conversion policy of the Govt. of NCT of Delhi and GGSIP University, New Delhi.

3. Counselling Schedule:

The Counselling of the Institute for admission against 10% Management Quota Seats, as approved by GGSIP University, New Delhi, shall be held on 11th August, 2019 at 10:00 a.m. (sharp). Reporting of candidates and document verification shall start at 09:00 a.m. Candidates are advised to report in advance, so that the document verification can be completed upto 10:00 a.m. Successful document verification is must for participation in the Counselling and eligibility for Seat Allotment. Late Comers will be allowed for the remaining vacancies (if any), only after exhausting the candidates, having completed the document verification upto 10:00 a.m. (sharp). Counselling will continue until all the Vacant Seats are filled. The Venue of the Cousnelling is Seminar Hall, Third Floor, E-Block, BVICAM, A-4, Paschim Vihar, Adjacent to Paschim Vihar (East) Metro Station, Rohtak Road, New Delhi-110063.

4. Eligibility Criteria:
